1. Providing Notification to Users under GDPR

As the owner of a website where Exponential are able to collect personal data from users, to comply with the GDPR, you need to provide notification to your users regarding personal data collection – and to continue working with Exponential, that means including Exponential's information too.

In essence, you will need to include a mini-version of Exponential's (and any other vendors you may be working with, of course) privacy policy. Please therefore include one of the following pieces of text in *your* privacy policy (or equivalent page) such that it is obvious to users.

1.1 Legitimate Interest

If you are using legitimate interest as the legal basis for our processing, use this text (including links):

Exponential Interactive, Inc, as our partner, have a legitimate interest to collect and profile personal data in the form of IP address and cookie ID from users on our website in order to provide targeted online advertising and ad measurement. For more details including opt-out requests, access requests or complaints, please review their <u>privacy policy</u> or contact their data protection officer via <u>privacy@exponential.com</u>.

1.2 Consent

If you are using consent as the legal basis for our processing, use this text (including links):

Subject to your consent, Exponential Interactive, Inc collect and profile personal data in the form of IP address and cookie ID from users on our website in order to provide targeted online advertising and ad measurement. You may change your consent decision at any time via <insert details of your consent mechanism or Consent Management Platform here>.
